The organization provided academic advisory to 46 SEALs, entrepreneur assistance to 22 SEALs, executive coaching to 33 SEALs, test preparation for 22 SEALs, scholarship funds to 25 SEALs and direct job placement for 13 SEALs. Of note during the reporting year were the following program enhancements: - Scholarship program was expanded to include non-degree executive programs and professional certifications - Career development support program was created to cover job seeking expenses such as travel - Special support program was established to assist transitioning SEALs experiencing hardships not supported by the military or other nonprofit organizations - Community development program was established to build supportive communities for transitioning SEALs nationwide, called SEAL Future Fund Forward Operating Bases
