During the reporting year, the organization provided its programs and services to 154 new SEALs, for a total of 352 served since inception. The organization provided academic advising to 39 SEALs, scholarship funds for 24 SEALs and direct job placement for 12 SEALs. Of note during the reporting year were the following program enhancements: The Warrior Health Program was established to provide SEALs with referrals to best-in-breed holistic treatment modalities to treat the effects of training and combat on mental health, physical health, spiritual health, family health and financial health. In addition to providing referrals to providers, the SFF financially sponsors various treatment modalities and wellness programs.
