Of note during the reporting year were the following program enhancements: The Warrior Health Program was established to provide SEALs with referrals to best-in-breed holistic treatment modalities to treat the effects of training and combat on mental health, physical health, spiritual health, family health and financial health. In addition to providing referrals to providers, the SFF financially sponsors various treatment modalities and wellness programs.
